**GROUP PERMIT AGREEMENT**

I hereby acknowledge and agree to follow the following:

1. The park or property will remain open to the public during group's events and activities.
2. Park only in the designated parking area or as instructed by Scenic Hudson.
3. Parks close at dusk. Please be off premises by that time or a time determined by Scenic Hudson.
4. Stay within the posted property boundaries.
5. Keep pets leashed at all times. Clean up after them.
6. Stay on designated trails.
7. Do not remove or destroy plants, wildlife, historic artifacts or structures.
8. Carry out what you carried in.
9. The use of all-terrain vehicles (ATVs), mountain bikes\*, horses, firearms is prohibited.
10. Swimming, hunting\*, camping, building of fires, dumping, and metal detecting are prohibited within the park.
11. All alcoholic beverages are prohibited.
12. Sound systems (without headphones), open flames (including candles), barbecues, electrical lighting, torches and lanterns are prohibited. Releasing balloons or any other such material is also prohibited.
13. There is no toilet facility. The applicant may arrange and pay for a portable toilet (number of units and their locations on site to be determined with Scenic Hudson). The unit(s) must be removed within 24 hours of the group activity.
14. Where applicable, Scenic Hudson would like to receive credit in any advertisements or promotional materials that are created. We also require that any such materials be provided to us for review and approval prior to distribution. Scenic Hudson will provide language as appropriate.
15. Scenic Hudson staff will inspect the site before and after the applicant's activity to insure that no damage has occurred. Applicant will assume full responsibility for any and all damages incurred by the group.
16. I and anyone else in my group indemnify, save and hold harmless, Scenic Hudson, Inc. and The Scenic Hudson Land Trust, Inc, and their agents and employees from any claims, demands, actions or causes of action whatsoever arising out of, or by reason of, the execution or performance of the services so provided and to defend at his/her own cost any action or proceeding commenced for the purpose of asserting any claim or whatever character arising out of this agreement.
17. Scenic Hudson reserves the right to add further restrictions and to close any park or cancel any scheduled event for any reason.

\* Mountain biking is allowed at Shaupeneak Ridge Park. Hunting is also allowed in season at Shaupeneak Ridge Park. A special permit is required for hunting. Please contact Vickie Muller at the information below with questions regarding hunting permits.
