A BILL

To amend the Act popularly known as the Rivers and Harbors Appropriation Act of 1915 to prohibit the establishment of certain anchorage grounds within five miles of a nuclear power plant, a location on the national register of historic places, a superfund site, or critical habitat of an endangered species, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Hudson River Protec-
5 tion Act”.

1 **SEC. 2. PROHIBITION ON ESTABLISHMENT OF CERTAIN AN-**
2 **CHORAGE GROUNDS WITHIN FIVE MILES OF**
3 **CERTAIN LOCATIONS.**

4 (a) IN GENERAL.—Section 7 of the Act of March 4,
5 1915 (chapter 142; 33 U.S.C. 471), popularly known as
6 the Rivers and Harbors Appropriation Act of 1915, is
7 amended—

8 (1) by striking “The Secretary” and inserting
9 “Except as provided in subsection (b), the Sec-
10 retary”;

11 (2) by redesignating subsection (b) as sub-
12 section (c);

13 (3) in subsection (c), as so redesignated—

14 (A) by striking “(c) DEFINITION.—As
15 used in this section” and inserting the fol-
16 lowing:

17 “(c) DEFINITIONS.—As used in this section—

18 “(1) the term”;

19 (B) by striking the period at the end and
20 inserting a semicolon; and

21 (C) by adding at the end the following:

22 “(2) the term ‘nuclear power plant’ means an
23 electric generating facility that uses a nuclear reac-
24 tor as its heat source to provide steam to a turbine
25 generator; and

1 “(3) the term ‘superfund site’ means a site that
2 is—

3 “(A) included on the National Priorities
4 List developed by the President in accordance
5 with section 105(a)(8)(B) of the Comprehensive
6 Environmental Response, Compensation, and
7 Liability Act of 1980 (42 U.S.C.
8 9605(a)(8)(B)); or

9 “(B) the subject of an ongoing or planned
10 remedial action carried out in accordance with
11 such Act.”; and

12 (4) by inserting after subsection (a) the fol-
13 lowing:

14 “(b) RESTRICTION.—The Secretary may not estab-
15 lish as anchorage grounds for vessels carrying hazardous
16 or flammable material as cargo any area that is located
17 within five miles of—

18 “(1) a nuclear power plant;

19 “(2) a location on the national register of his-
20 toric places;

21 “(3) a superfund site; or

22 “(4) a critical habitat of an endangered species
23 designated under the Endangered Species Act of
24 1973 (16 U.S.C. 1531 et seq.).”.

1 (b) LIMITATION ON APPLICATION.—The amendment
2 made by subsection (a) shall not apply with respect to an-
3 chorage grounds established before the date of the enact-
4 ment of this Act for vessels carrying hazardous or flam-
5 mable material as cargo.
