

## **Environmental Protection Fund Investments in Greene County Enhancing Our Economy and Protecting Clean Drinking Water**

The Environmental Protection Fund (EPF) has provided more than \$1 billion since 1993 to support critical programs that protect our area's natural resources, public health, and local industries including tourism. Our local economy and good quality jobs have been enhanced and supported thanks to the EPF, which has injected \$6.2 million into our local economy. Below are a few examples of how the EPF has paid off for Greene County:

- **\$1.2 million** has been invested in developing and expanding the Catskill Forest Preserve, one of Greene County's premier natural resources and world-class recreational area. From North-South Lake to Hunter Mountain to Kaaterskill Falls and the Long Trail, EPF funding increases resident and visitor access to four-seasons of recreation from canoe and kayak rentals, biking, hiking, swimming, fishing and summer nature recreation programs to cross-country skiing, snowshoeing, snowtubing, snowmobiling, incredible ice climbing and ice skating.
- Provided over \$2.6 million toward waterfront revitalization and water quality in the Village and Town of Athens, Coxsackie, Durham, Catskill to improve public access and provide an active, creative and educational experience for Greene County residents and visitors alike.
- Nearly \$1 million toward in Maplecrest, Windham, Village Athens and assisting other Greene county municipalities with funding mandated programs including properly closing an old, inactive landfill in Hunter in order to prevent groundwater pollution in residential drinking water
- √ \$1 million has been deployed to preserve and develop Greene County parks and agricultural landscapes in the Village and Town of Athens, Sherman, Maplecrest, Coxsackie, New Baltimore, Windham, Durham, Hudson and Catskill
- ✓ An additional \$500.000 has protected and improved our county's historic places and houses including one of the most important stories on the world famous Hudson River School Art Trail, the Thomas Cole National Historic Site.
