## Warranty/Disclaimer

- 1. The Data are provided "as is" and "as available. Scenic Hudson does not warrant or guarantee the accuracy, completeness or reliability of the Data and shall not be held liable for use of the data described and/or contained herein for any purpose or for improper or incorrect use.
- The metadata file for each data set should be reviewed to understand the sources and limitations of the Data. The sources and limitations of the Data (including any limitations on the accuracy thereof) should be taken into account before using them in any analysis or for any purpose.
- 3. By acceptance of the terms of this Agreement, the entire risk associated with use, results and performance of the Data is assumed by the User.
- 4. The Data are subject to change without notice. Users should be aware that temporal changes may have occurred. The Data cannot be relied on as a definitive statement of actual conditions and should not be substituted for on-site surveys or analysis by qualified professionals.
