

## **SCENIC HUDSON GIS DATA SHARING AGREEMENT**

This agreement establishes the terms and conditions of cooperation between the Licensed User and Scenic Hudson, Inc. and/or the Scenic Hudson Land Trust (collectively "Scenic Hudson"), respecting the sharing and management of Geographic Information System (GIS) data. By act of downloading this data, all users agree to abide by the terms and conditions of the Scenic Hudson GIS Data Sharing Agreement.

Regarding all GIS data obtained from Scenic Hudson, the Licensed User(s) specifically agrees to the following terms and conditions governing any access to and use of the data:

### **Permitted Uses**

1. The data being provided is for analytical purposes and should not be used for the production of maps for commercial purposes. The data provided in this release shall not be modified except as needed to make them compatible with the Licensed User's geographic information system.
2. The digital data provided is to be accessed only by staff of the Licensed User or their authorized agents, and for internal use for the purposes of land use decision-making, conservation planning and analysis. Access and use for other purposes, including by the Licensed User, will be made only with prior written arrangements with Scenic Hudson

### **Sharing and Distribution**

3. Scenic Hudson provides this data for fair-use purposes only. Any sale, distribution, loan or offering for use of these digital data, in whole or in part, is prohibited without the approval of Scenic Hudson. The use of these data to produce other GIS products and services with the intent to sell for a profit is prohibited without the written consent of Scenic Hudson. All parties receiving these data must be informed of these restrictions. Scenic Hudson shall be acknowledged as data contributors to any reports or other products derived from these data.
4. The data are not for resale or redistribution either electronically or in printed format other than in reports or analyses citing Scenic Hudson as the primary source and custodian of the data. Such data shall be used only for lawful purposes.
5. The Licensed User will notify Scenic Hudson of any value-added or new map products generated from the geographic data provided by Scenic Hudson to the Licensed User, and agrees to provide Scenic Hudson with said product subject to the Scenic Hudson and the Licensed User entering in to a similar Data License Agreement with respect to the transfer of such new data to Scenic Hudson by the Licensed User

6. The data provided in this release must reside on the data system of the Licensed User and should not be copied, distributed, or made accessible in digital form to other parties. Requests by other parties for these digital data will be referred directly to Scenic Hudson.

The data and/or maps provided in this release are provided “as is.” Scenic Hudson does not warrant or guarantee the accuracy, completeness or reliability of the content on this website and shall not be held liable for use of the data described and/or contained herein for any purpose. The sources and limitations of the data (including any limitations on the accuracy thereof) should be taken into account before using them in any analysis. **By acceptance of the terms of this agreement, the entire risk associated with use, results and performance of these data and maps is assumed by the Licensed User.**

Should a discrepancy develop between the data provided to the Licensed User and the data Scenic Hudson maintains, the data maintained by Scenic Hudson will be considered correct.
