(i) To administer funds entrusted to its care for the endowment of specific areas or for carrying out the other purposes of the Corporation.

(j) To work with and through, and to coordinate the efforts of, other organizations and individuals, to become a member of any committee or other organization, and to delegate functions.



·. . ' CERTIFICATE OF AMENDMENT OF THE CERTIFICATE OF INCORPORATION OF THE SCENIC HUDSON LAND TRUST, INC.

#### Under Section 803 of the Not-For-Profit Corporation Law

I, the undersigned, being the President of The Scenic Hudson Land Trust, Inc., do hereby certify:

(1) The name of the corporation is The Scenic HudsonLand Trust, Inc. (the "Corporation").

(2) The Corporation's Certificate of Incorporation was filed by the Department of State on September 3, 1936. The Corporation's Certificate of Incorporation was amended by a Certificate of Change of Purposes that was filed by the Department of State on November 14, 1961, and Certificates of Amendment that were filed by the Department of State on October 1, 1982, November 15, 1983, and February 4, 1991. The Corporation was formed under the Membership Corporation Law of the State of New York, which was superseded by the Not-for-Profit Corporation Law effective September 1, 1970.

(3) The Corporation is a corporation as defined in subparagraph (a)(5) of section 102 of the Not-For-Profit
 Corporation Law and is a Type B corporation under section 201 of said law.

(4) Subparagraph (3) of paragraph 12 of the Corporation's Certificate of Incorporation, which describes dissolution of the Corporation, is hereby amended to read in its entirety as follows:

"(3) Upon the liquidation or dissolution of the Corporation or the winding up of its affairs, whether voluntary, involuntary or by operation of law, no trustee or officer of the Corporation shall be entitled to any distribution or division of its property or any part of the proceeds therefrom. The money and all other property of the Corporation after the payment of all its debts and obligations of whatsoever kind or nature, shall be distributed to Scenic Hudson, Inc., or if, at such time, Scenic Hudson, Inc. does not exist or is not exempt from Federal income tax under Section 501(c)(3) of the Code, then to one or more organizations (a) which are exempt from Federal income tax under Section 501(c)(3) of the Code, (b) whose general purposes are in harmony with the general purposes set forth in Paragraph 2(c), and (c) which, if the Corporation at that time is a private foundation within the meaning of Section 509(a) of the Code, are organizations described in Section 170(b)(1)(A) (other than clauses (vii) and

(viii) thereof) of the Code."

(5) A new paragraph 13 is hereby added to set forth the membership structure of the Corporation, and shall read in its entirety as follows:

"13. Pursuant to Section 601 of the Notfor-Profit Corporation Law, the Corporation shall have a sole member, which shall be Scenic Hudson, Inc., a New York not-for-profit corporation."

(6) The foregoing amendments to the Certificate of Incorporation of the Corporation were authorized by the vote of a majority of the members of the Corporation at a duly called meeting of the membership.

(7) The Secretary of State of the State of New York is hereby designated the agent of the Corporation upon whom process against it may be served. The post office address to which the Secretary of State shall mail a copy of any process which is served on him is:
